

OFFICIAL PROCEEDINGS: Hancock County Board of Supervisors

HANCOCK COUNTY BOARD OF SUPERVISORS December 16, 2019 Garner, Iowa

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The minutes of December 9, 2019 meeting were read and approved.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman, and carried unanimously, the Board gave approval to the following: Transfer of \$50,000 from Hancock County Medical Benefit Account to Hancock County Medical Benefit Fund. Hiring of Seth Goepel, Second Mechanic, Secondary Road Department, effective December 30, 2019 at \$22.00 per hour. Quote for temperature control system and possible replacement of zone valves for Law Enforcement Center from FM Controls, Fort Dodge, in an amount not to exceed \$18,600.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons, and carried unanimously, the Board gave approval to the following: Payroll change for Trent Maakestad, Secondary Road Department, completion of probationary period effective December 22, 2019 at \$21.67 per hour. Quote from B & W Control Specialists, Algona, for tree and brush control in open drainage ditches in the amount of \$44,750.
