

# PROCEEDINGS: Hancock Co.

**HANCOCK COUNTY  
BOARD OF SUPERVISORS  
December 2, 2019

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman and Gary Rayhons present. Supervisor Jerry J. Tlach arrived at 9:11 a.m. Absent: none.

The minutes of November 25, 2019 meeting were read and approved by Supervisor Greiman and Rayhons. Absent: Tlach.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons, and carried unanimously, the Board gave approval to the following: Hiring of Larry Treinen, Maintenance, effective December 9, 2019 at 7:30 a.m. at \$16.00 per hour.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman, the Board motioned the following: Approved Hancock County Policy Regarding Weather Emergencies with employees to take paid/unpaid leave time for the duration the Courthouse is closed. Ayes: None. Nays: Greiman, Rayhons, Tlach. Motion did not pass.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman, and carried unanimously, the Board gave approval to the following: Approved Hancock County Policy Regarding Weather Emergencies with an amendment to the

third paragraph now stated as "If the Chairperson declares a weather emergency before or during the work day, all Department/Office employees, not employed in essential county functions, shall leave and employees shall be required to take paid/unpaid leave time for the duration of the emergency.

On motion by Supervisor Rayhons, seconded by Supervisor Greiman, and carried, the Board authorized the County Auditor to issue checks for the claims on file this date, December 2, 2019. A full listing of all claims paid in December, 2019 will be published in December 16, 2019 minutes.

On motion by Supervisor Greiman, seconded by Supervisor Rayhons, and carried unanimously, the Board recessed for lunch at 11:30 a.m. and resumed again at 1:00 p.m. at the Basement Meeting Room in the Law Enforcement Center for a formal hearing with landowners of Joint Drainage District no. 13-128 with Cerro Gordo County Board of Supervisors.

No further business to come before the Board, motion made to adjourn at 2:08 p.m. by Supervisor Greiman and carried. All Supervisors present voting, "Aye," session to adjourn and will meet again on December 9, 2019.
