

# PROCEEDINGS: Hancock Co.

**HANCOCK COUNTY  
BOARD OF SUPERVISORS  
March 23, 2020  
Garner, Iowa**

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman and Gary Rayhons present. Supervisors Jerry J. Tlach present via GoToMeeting. Absent: none.

The minutes of March 18, 2020 meeting were read and approved.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach, and carried unanimously, the Board gave approval to the following: Revised Hancock County Secondary Road's Iowa Department of Transportation 5-year construction program for Fiscal Years 2021-2025. Signed Wellmark document: Wellmark rate sheet. Approved increase in health insurance rates of 10.4% for Fiscal Year 2020-2021. Approved increase in dental insurance rates of 2% for Fiscal Year 2020-2021. No change, from Fiscal Year 2019-2020, to the calculation of the employee's contribution to dental and vision for Fiscal Year 2020-2021.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons, and carried unanimously, the Board gave approval to the following: Signed Wellmark document: Medicare Secondary Payer (MSP) Addendum sheet. Approved increase in vision insurance rates of 3% for Fiscal Years 2020-2021 and 2021-2022. Approved the City of Garner using the parking area north of the Hancock County Health Building (545 State Street, Garner) for City of Garner's E-Waste event on May 18, 2020 from 3:00 to 6:00 p.m. as long as the property owner north of the Hancock County Health Building also consents to use of their property. Removed the provision in the personnel policy requiring medical verification of illness for absences of three or more continuous days for the duration of the declaration of

State of Emergency for Hancock County, Iowa.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach, and carried unanimously, the Board gave approval to the following resolution:

**RESOLUTION NO. 2020-015  
HOMESTEAD AND/OR MILITARY TAX  
CREDIT APPLICATION**

WHEREAS, pursuant to Code of Iowa, Chapters 425 and 426A the Board of Supervisors is empowered to establish by resolution that any person may request, in writing, from the Hancock County Assessor, forms for the filing of Homestead Tax Credit and/or Military Service Tax Exemption; and,

WHEREAS, it is in the best interest of the residents of Hancock County to be allowed to make such written requests, through regular mail or electronic mailing; and,

NOW THEREFORE, BE IT RESOLVED by the Hancock County Board of Supervisors as follows:

Section 1. That pursuant to Code of Iowa, Chapters 425 and 426A any person may request, in writing, from the Hancock County Assessor, forms for the filing of Homestead Tax Credit and/or Military Service Tax Exemption.

Section 2. That the forms may be made available by the assessor's office and may also be accessed online through the Hancock County Assessor website.

Section 3. This resolution shall be effective upon passage by the Hancock County Board of Supervisors.

No further business to come before the Board, motion made to adjourn at 12:23 p.m. by Supervisor Rayhons and carried. All Supervisors present voting, "Aye," session to adjourn and will meet again on March 26, 2020.
