

PROCEEDINGS: Hancock Co.

HANCOCK COUNTY BOARD OF SUPERVISORS September 8, 2020 Garner, Iowa

The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Gary Rayhons, and Jerry J. Tlach present. Absent: none.

The Hancock County Board of Supervisors met for a Joint Meeting at Cerro Gordo County Board of Supervisors' Office, Mason City for a hearing with landowners of Joint Drainage District no. 123-113 and Cerro Gordo County Drainage District no. 16. Present: Cerro Gordo County Board of Supervisors, Chris Watts, Casey Callanan and Tim Latham, Absent: none, and Hancock County Board of Supervisors, Florence (Sis) Greiman, Gary Rayhons, and Jerry Tlach, Absent: none; motion by Supervisor Callanan, seconded by Supervisor Watts and carried unanimously, the Joint Board gave approval to the following: Directed the engineer to prepare final plans and specifications for Cerro Gordo County Drainage District no. 16, directed engineer to send notifications to landowners of Joint Drainage District no. 123-113 to obtain wetland determinations, and to continue the hearing for Joint Drainage District no. 123-113 to a future date once determinations are completed.

On a Tri-joint teleconference with Franklin County Board of Supervisors, Gary McVicker, Corey Eberling, and Michael Nolte, Absent: none, Cerro Gordo County Board of Supervisors, Casey Callanan, Tim Latham and Chris Watts, Absent: none, and Hancock County Board of Supervisors, Florence (Sis) Greiman, Gary Rayhons, and Jerry Tlach, Absent: none; motion by Supervisor Watts, seconded by Supervisor McVicker and carried unanimously, the Tri-Joint Board gave approval to the following: Approved the drainage levy assessment for Tri-Joint Drainage District no. 86-1-31 Lateral 4 Upper Tile in the amount of \$10,500.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried unanimously, the Board recessed at 10:48 a.m. until 1:00 p.m. to travel back to Hancock County for the remainder of the Hancock County Board of Supervisors' meeting.

The minutes of August 31, 2020 meeting were read and approved.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons and car-

ried unanimously, the Board gave approval to the following: Opted out of the Social Security Tax Deferment. Correction to the certification of drainage district levies for collection with Fall taxes in 2020 for Drainage District no. 38 Lateral A-1-3 from \$10,000 to \$0 and to levy for collection with Fall taxes in 2021 for Drainage District no. 38 Lateral A-2 Tile and Surface Drain for the repair. Approved the issuance of one improvement certificate numbers 467 for Marvin J. Young for Drainage District no. 7 Lateral 255. Approved the issuance of one improvement certificate numbers 469 for Marvin J. and Jacqueline S. Young for Drainage District no. 81 Main Open Ditch.

On motion by Supervisor Rayhons, seconded by Supervisor Tlach and carried unanimously, the Board gave approval to the following: Signed Hancock County Foundation Grant Application for Hancock County Sheriff's Department in the amount of \$6,652.50.

Approved the following changes to Nationwide 457(b) plan for the SECURE Act effective January 1, 2020: within one year of qualifying birth or adoption of a child, individuals may make a penalty-free withdrawal of up to \$5,000 and participants can now take in-service distributions from their plans after attaining age 59 .. Approved the issuance of one improvement certificate numbers 468 for Marvin J. and Jacqueline S. Young for Drainage District no. 5 Main Open Ditch. Approved the issuance of one improvement certificate numbers 470 for Marvin J. and Jacqueline S. Young for Drainage District no. 81 Main Tile. Signed Iowa Secretary of State Vote Safe Iowa Initiative Grant Agreement in the amount of \$16,600.

On motion by Supervisor Tlach, seconded by Supervisor Rayhons, and carried, the Board authorized the County Auditor to issue checks for the claims on file this date, September 8, 2020. A full listing of all claims paid in September 2020 will be published in the September 21, 2020 minutes.

No further business to come before the Board, motion made to adjourn at 3:37 p.m. by Supervisor Tlach and carried. All Supervisors present voting, "Aye," session to adjourn and will meet again on September 14, 2020.
